## **Attention Downtown Raleigh HBRs: State Health Plan Road Tour with Aetna Coming to Downtown Raleigh**

The State Health Plan (Plan) is partnering with Aetna, the Plan's new Third-Party Administrator beginning Jan. 1, 2025, for a 25-stop tour of the state to meet with state employees and teachers about the benefits and enhanced programs offered to Plan members beginning in January.

**The road tour, featuring Aetna-themed vehicles, will be in downtown Raleigh on August 22 at the Bicentennial Plaza from 11 a.m. to 3 p.m.** The road show will then travel the state from late August through late October with stops in Charlotte, Wilmington, Asheville, Winston-Salem, Fayetteville and numerous other locations.



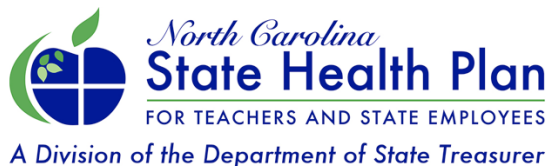
Plan members will have the opportunity to learn more about Aetna and ask questions prior to the 2025 Open Enrollment period, which will be held Sept. 30-Oct. 25, 2024. Flu shots will also be available while supplies last. Representatives from Eat Smart Move More Weigh Less will also be onsite to offer details about the program.
