**New Qualifying Life Event
Functionality in eBenefits**

This weekend Benefitfocus will be enhancing their qualifying life event functionality in the eBenefits platform.

Now, when a subscriber clicks into one of their benefits from the “at a glance” section on their homepage, they will see a new content section around how to make changes to the benefit.

The text will clearly state if the benefit will require a life event to make changes, along with a list of qualified life events that will allow the subscriber to initiate a life event change. If the subscriber does initiate a life event from this screen, they will then be taken through an enhanced life event workflow.

Below are screen shots of the enhancement:

From the member role home page, click “Get started.”

Life events are significant moments (e.g. birth of a child) that might require you to make a change to your benefits. A life event is often, but not always, required to make changes to most benefits.
