Time is Running Out! Open Enrollment Ends Saturday!

If you have already taken action to complete your Open Enrollment elections, thank you! You may disregard this message.

Open Enrollment ends Saturday, October 31! Have you taken action? Click the blue button below to complete your enrollment ONLINE!

All active and non-Medicare members will be moved to the 70/30 Plan for the 2021 benefit year. Members will need to take action during Open Enrollment if they want to enroll in the 80/20 Plan or reduce their monthly premium in either plan.

Please note that the 70/30 Plan remains premium-free for eligible non-Medicare retirees.

Important Highlights for 2021:

- No premium increases for the 3rd year in a row!
- Members who select a [Clear Pricing Project](#) Provider as their Primary Care Provider will enjoy a \$0 copay!
- Reduced copays for members who visit a Clear Pricing Project Specialist!
- Preferred and non-preferred insulin will have a \$0 copay for a 30-day supply!
- Preventive Services remain free – no copay or deductible – on the 80/20 and 70/30 plans!

The Eligibility and Enrollment Support Center (855-859-0966) is open **TODAY until 10 p.m.** and offers extended hours for Open Enrollment (all times ET):

- Monday-Friday, 8 a.m.-10 p.m.
- Saturday, 8 a.m.-5 p.m.

Please do not wait until Saturday to take action and call or you will experience longer hold times.

For subscribers who need to complete their tobacco attestation counseling session, you have until November 30, 2020, to visit a Primary Care Provider (PCP) or a CVS MinuteClinic in order to receive your premium credit for 2021.

CVS MinuteClinic is now able to conduct virtual tobacco attestation counseling sessions in North Carolina! Subscribers interested in this service should [click here](#) to request a virtual session.

As a reminder, if you are not a tobacco user, you will just need to attest to that through your online enrollment process.

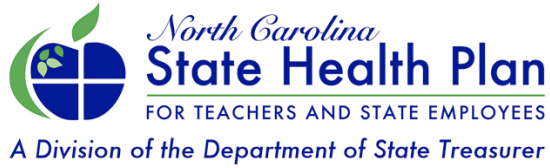
