#### **Get Ready for Open Enrollment!**

(All Members)

It's almost time! Open Enrollment for the 2025 benefit year will be held Sept. 30 to Oct. 25, 2024. As a reminder, starting Jan. 1, 2025, the State Health Plan's Third-Party Administrator (TPA) will transition from Blue Cross NC to Aetna.



This transition impacts members enrolled in the Base PPO Plan (70/30), Enhanced PPO Plan (80/20) and the HDHP, including Medicare retirees enrolled in the Base PPP Plan (70/30). This does not impact members enrolled in the Humana Medicare Advantage Plans.

Open Enrollment information is now available on the Plan's <u>website</u> including upcoming events, which start in late August and continue through late October.

## Reminder! Tobacco Users Can Get a Head Start on Open Enrollment!

(Active Members)

Members who are tobacco users and want to earn their monthly premium credit for 2025 don't have to wait until Open Enrollment this fall. They can take action now to save money throughout 2025!

Tobacco users can attend a tobacco cessation counseling session at their Primary Care Provider's (PCP) office for FREE to earn a lower premium for 2025. They have until Nov. 30, 2024, to take action. (Note: If members combine their tobacco cessation visit with another service, there may be a copay.)

This convenient option means there's no need to wait for Open Enrollment in October to secure their monthly premium credit for 2025.

#### How it works:

- After employees visit a PCP for their tobacco cessation session, the provider
  will submit a claim on their behalf. To ensure they receive credit for their visit,
  employees should upload their office visit summary to the "Document Center"
  located in <a href="mailto:eBenefits">eBenefits</a>, the State Health Plan's enrollment system. They should
  make sure to request a copy of their summary during their visit.
- This option is **ONLY** for tobacco users who want to reduce their monthly premium by \$60 per month in 2025.
- If employees are NOT tobacco users, they will simply attest to that online during Open Enrollment, Sept. 30 to Oct. 25, 2024.
- During Open Enrollment, they will attest during the online enrollment process.
   This step is critical to ensure employees receive the lower premium for 2025.Members

#### **Eat Smart, Move More, Weigh Less**

(Active Members)

<u>Eat Smart, Move More, Weigh Less</u> is a 15-week weight management program delivered online in real time by a live Registered Dietitian (RDN) instructor. Lunchtime and evening classes are available beginning the week of Sep. 1.

Active State Health Plan members who live in North Carolina are eligible to **participate at no cost** with the code **GNC2024**. Click <u>HERE</u> to register and to see available class times.



\*Active State Health Plan employees can register at no cost. Retirees covered by Humana are not eligible for the discount. Employees will be asked to enter their State Health Plan subscriber ID number and a claim will be filed for their participation in the program.

### **Eat Smart, Move More, Prevent Diabetes** (All Members)

<u>Eat Smart, Move More, Prevent Diabetes</u> is a 12-month, CDC-recognized Diabetes Prevention Program delivered online in real-time by a trained lifestyle coach. Lunchtime and evening classes are available beginning the week of Sep. 8.

State Health Plan members who live in North Carolina are eligible to **participate for only \$30**, with a **full refund** for completing the program and tracking requirements. **No coupon/voucher code is needed.** Click <u>HERE</u> to register and to see available class times.
